



MEDICAL TREATMENT RIGHTS

1. GOVERNMENT OFFICER RIGHTS



Can use the benefit for direct billing through the Comptroller General's Department.



Government officers and their family members are eligible to use this right.

Please present your ID card at the payment counter.



Service fees are charged according to the rates set by the Comptroller General's Department

Users are responsible for any additional fees not covered (if any).



For family members under 7 years old:

Eligible with birth certificate and guardian's ID card, presented at the payment counter



If required documents are missing

The patient will be responsible for the cost of service and reimbursement cannot be made.

MEDICAL TREATMENT RIGHTS

2. SOCIAL SECURITY RIGHTS



Coverage of up to 900 THB/year
For services including dental scaling, tooth extraction, and fillings.

(No reimbursement required)



Eligible users can access benefits by presenting their Thai National ID Card at the payment counter.

PROSTHODONTIC SERVICES

- Partial dentures (1–5 teeth): Covered up to 1,300 THB
- Partial dentures (more than 5 teeth): Covered up to 1,500 THB
- Complete upper or lower dentures: Covered up to 2,400 THB
- Complete upper and lower dentures: Covered up to 4,400 THB

(Only once every 5 years, with proper documentation and explanation for necessity and benefit)

Service Conditions

You must register this hospital as your designated provider in the Social Security system.

Indicate: "**Faculty of Dentistry, Khon Kaen University**"

MEDICAL TREATMENT RIGHTS

3. Universal Health Coverage (UHC) Rights



This right can only be used at the teaching clinic.



To use this benefit, patients must verify and confirm their identity every time
at the registration point before treatment.



Required documents for identity verification

1. National ID card
2. For children aged 7–15: ID card of the patient and guardian
3. For children under 7: Birth certificate of the patient and guardian's ID card



If these documents are not provided,
the patient must pay the full service fee.



For critical conditions such as cancer, severe oral or facial pain, or surgical procedures, a referral letter from the primary hospital is required.

Must clearly state: "Faculty of Dentistry, Khon Kaen University"

MEDICAL TREATMENT RIGHTS

4. Rights for Bank of Thailand Employees



Eligible individuals can use their rights by presenting their Bank of Thailand employee card along with their national ID card at the registration and payment counters **every time.**

MEDICAL TREATMENT RIGHTS

5. State Enterprise Rights / Government Agency Reimbursement Rights



The service recipient must pay for the medical expenses in advance and request a medical certificate to claim reimbursement from their respective agency.

MEDICAL TREATMENT RIGHTS

6. Rights for Local Government Officials (LGOs) / Personnel of the National Health Security Office (NHSO) / Bangkok Metropolitan Administration Officials



Eligible individuals can directly claim medical expenses according to the regulations of the Comptroller General's Department.



Government officials and their family members are eligible to use the medical benefits.
By presenting a national ID card or an official government-issued document at the medical records room and the payment counter.



For family members under 7 years of age

Eligible to use the benefits by presenting a birth certificate or an official government-issued document at the medical records room and the payment counter.



If no supporting documents are available

The service recipient must pay for the medical expenses in advance and claim reimbursement from their respective agency.

MEDICAL TREATMENT RIGHTS

7. Service recipients holding a health insurance card and entitlements under the Motor Vehicle Accident Victim Protection Act (Compulsory Motor Insurance Act).



Service recipients must pay for medical expenses upfront and request a medical certificate.

for reimbursement from the insurance company.



The coverage under the Motor Vehicle Accident Victim Protection Act (Compulsory Motor Insurance) is limited to a maximum of 30,000 baht.

Claims must be filed within 6 months from the date of the accident.



Claiming medical expenses with private insurance

Subject to the terms and conditions of the insurance policy held.
